

Confession of mass murder

Message of political prisoner Golrokh Iraei /

June 9, 2024

"I was one of those who shot people we killed. Now, who wants to judge us?" This is not a part of the dialogue of a movie. This is Hassan Nowrozi, one of the few vice-chairmen of the Judicial Commission of the Islamic Republic of Iran, who talks about the people killed in Aban like this. - Mustafa Pourmohammadi, who was the prosecutor of Hormozgan, Kermanshah, Khuzestan, and Khorasan in the 1980s, and his laughter on death row and his bargaining over the execution of people, will forever echo in our ears and the ears of history. A figure who, in addition to being in the four-person team of death (summer 1988), also had a prominent role in serial murders.

-Mohammad Baqer Qalibaf, a famous figure among financial corruptors, a club-wielder who is proud to have gassed students on the street in University Crimes (1999) and has long recorded the summoning, interrogation and arrest of intellectuals and journalists.

- Alireza Zakani, whatever financial corruption and his performance will be forgotten, his presence in the crimes of "University Quay" and the abuse of child laborers and garbage collectors as cheap labor will not be erased from his mind during his management period in the municipality. We live in this horrible atmosphere, and these kinds of people occupy government positions, and we get killed. Our murderers are not only not punished, but a memorial ceremony is held for them in the United Nations. This is the election atmosphere that dictators create

so that they can claim people's participation in their destiny while dictating their will to society.¹..



Issuance of death sentence

Mohammad Khezrnejad-

June 6, 2024-Kurd Urmia Prison

The Supreme Court of Iran "confirmed."

the death sentence of Mohammad Khezrnejad, a Sunni cleric arrested during protests two years ago in Iran.

The Harana website, the news agency of the Human Rights Activists Group and the "Kordpa" news site, which covers the events of the Kurdish regions of Iran, published this news on Thursday, June 6, 2024. According to these reports, Ali Razini, the judge of the Supreme Court of the Islamic Republic of Iran, "confirmed" the initial death sentence issued against Mr. Khadranjad. Two months after the death of Mahsa (Zina) Amini in the custody of the Irshad patrol, which led to the protests of "Women, Life, Freedom" in Iran, Khadranjad was arrested along with her child at her place of residence in the city of Bukan in West Azerbaijan

province. Since then, He is currently in prison in Urmia. Shortly before his arrest, this Kurdish cleric had given a speech at the funeral of Asad Rahimi, who was one of the protesters killed in the Bukan events.²

An informed source told Radiofarda that this 45-year-old cleric from Bukan was also sentenced to 15 years in prison on the charge of "damaging the integrity or independence of the country" and to one year in jail on the charge of "propaganda against the regime." According to this source, the last court session of this Sunni Kurdish cleric was held in the form of a "video conference" and "without the presence of a lawyer" this November.

ماموستا محمد خضرزاد، روحانی اهل سنت گرد در ایران

شماری از روحانیان اهل سنت گرد با ارسال نامه‌ای مشترک به رئیس فقه‌تیمه جمهوری اسلامی، صدور حکم اعدام برای ماموستا محمد خضرزاد را «ناعادلانه» خواندند و خواستار آزادی او شدند.

در این نامه که به اعضای ۲۴۴ روحانی اهل سنت گرد (ماموستا) رسیده، از رئیس فقه‌تیمه ایران خواسته شده است که رسیدگی به اتهامات آقای خضرزاد به جای دادگاه انقلاب در دادگاه ویژه روحانیت و به صورت علنی برگزار شود.

Farhad Begi Grossi, a Kurdish citizen following the Yarsan Faith and one of the detainees of the Women, Life, Freedom movement in Sahne city of Kermanshah province (Kermanshah), due to continuous pressure from the security institutions of the Islamic Republic of Iran and also a summons for arrest and transfer to Evin prison. He committed suicide and ended his life. According to the report received by the human rights organization Hengao on Saturday (June 8, 2024), Farhad Begi Grosi, a 21-year-old

Kurdish citizen and a follower of the Yarsan religious minority, who was detained during the Gen Xian Azadi movement for more than a year, died at home. His family, located in the city, hanged him and ended his life.

According to an informed source, over the past four months, Farhad Begi Grossi has been under continuous pressure from the security institutions of the Islamic Republic of Iran, and recently it was announced to him that he should present himself to Dizilabad prison in Kermanshah and from there to Evin prison in Tehran. It should be noted that Farhad Begi Grossi was arrested in the fall of 2022 during the Women, Life, Freedom movement and was released last winter after more than a year of detention on bail and temporarily until the court session. He was accused of "participating in the murder" of Nader Bayrami, the intelligence chief of **the Sahne Corps**.

Reza Rasaei was also sentenced to death for the same charge and is currently imprisoned in Dizelabad Prison, **Kermanshah**.⁵⁶

Urmia/ Confirmation of Adham Ozdemir's death sentence in the Supreme Court of the Iranian regime!

Over the past few days, the death sentence of **Adham Ozdemir, 27 years old, from Bakur Kurdistan and imprisoned in Urmia prison**, was confirmed

by the Supreme Court of the Islamic Republic of Iran. It should be remembered that this Kurdish political prisoner was sentenced to death on March 15, 2022, by Branch 3 of the Islamic Revolution Court of Urmia, headed by Judge Najafzadeh, after 33 months of imprisonment. Previously, the first branch of the Islamic Revolution Court had sentenced Khoi to death on charges of rebellion, but the Supreme Court overturned this sentence in February 2023. This militant man was kidnapped by the Iranian Revolutionary Guards Corps on June 23, 2019, in the Korspi area in the Qalanieh region.

Farzane Qarahasanlou

Hunger strike

went on a hunger strike due to the denial of medical treatment in prison on **June 9, 2024**

Farzaneh Qarahasanlou, one of the detainees of the Zina uprising, imprisoned in **Vakil Abad prison of Mashhad**, started a hunger strike on Sunday, June 9, 2024. This political prisoner, whose left side of the body has become completely numb, began his hunger strike in protest of the denial of medical procedures and the lack of a doctor's examination. Despite repeated requests, he only has access to painkillers in the dire conditions of Vakil Abad Shiraz prison. Hamid Qarahasanlou and Farzane Qarahasanlou, who were arrested during the 40th Najafi Hadith ceremony in Karaj, are in poor conditions and are in a worrying state of health due to beatings and torture in detention. The government of Iran has arrested 21 people on the charge of killing a Basij member who was killed on the 40th day of Najafi's Hadith, and in the indictment, they have charged all these people with "corruption in the land." Their plaintiff is also the Ministry of Information. Mohammad Mahdi Karmi was one of those arrested in this case whose death sentence was executed.

Hamid Qarahasanlou, a doctor, and his wife, Farzane Qarahasanlou, are well-known philanthropists from Karaj. **According to the documents provided to Zamane, he has been very active in various school projects in**

underprivileged areas and in providing medical equipment for medical centers⁷.
