### Hitting a 14-year-old girl's head against a cement pillar

Insaf News site has published a video from a closed-circuit camera that shows the arrest and beating of a 14-year-old teenager by Hijab agents. According to Insaf News, this girl was beaten on June 21, 2024, in North Watanpour Street in Tehran. The mother of this teenager said that her daughter's head hit an electric pole during the fight, and when she was arrested, the fights with her daughter continued inside **the van.**<sup>1</sup>

The judicial authorities gave this video to the family. The purpose of this delivery of Dorian's closed street circuit to the family is to pretend that the regime has shown that the situation has changed a little by showing the fake presidential elections in recent days, and secondly, that they are not afraid of showing the crime and can claim that this action The agent was reckless and arbitrary and we are following up. Maryam Abbasi, the mother of this girl, who provided the video to Insaf News, said that her daughter was beaten on the 1st of July in North Watanpur Street in Tehran.

The mother of this 14-year-old teenager noted in the description of her daughter's arrest and beating: On the 1st of July, while her 14-year-old daughter and her friend were hiding behind the electric pole so as not to be seen, the "Ershad Police Van" came to them and violently drove them. She drives a van so that an electric pole hits her daughter's head.<sup>3</sup>

The fate of Jina Amini, who was murdered in the same way, or Armita, as hundreds of girls, could be the destiny of this teenage girl. The mother of this teenage girl, whose name is Nafas Haji Sharif, told Insaf News that when she

went to the moral security police at 8:00 PM following her girlfriend's call, she found her daughter in a bad state. She said: "I saw my daughter with a scarred face, swollen lips, a bruised neck, torn clothes, and a voice that could not be heard. She couldn't open his eyes; She was crying so **much.**"<sup>4</sup>

### **Shocking secret execution of young man from “Women, Life, Freedom” uprising**

- Iranian Kurdish man Reza (Gholamreza) Rasaei is at risk of execution concerning the September to December 2022 nationwide protests in Iran. Following a grossly unfair trial, on 7 October 2023, Branch Two of Criminal Court 1 of Kermanshah province relied upon his torture-tainted forced “confessions” as admissible “evidence” to convict him of “murder” and sentenced him to death.

- Responding to reports that the Iranian authorities this morning (6 August) arbitrarily executed Reza Rasaei, a 34-year-old member of the oppressed Kurdish and Yaresan ethnic and religious minorities, in connection to the “Woman Life Freedom” uprising of September-

December 2022, without providing prior notice to him, his family or his lawyer, **Diana Eltahawy, Amnesty International's Deputy Director for the Middle East and North Africa**, said:

- “While global and domestic media attention have been focused on regional tensions with Israel, the Iranian authorities have carried out the horrendous arbitrary execution in secret of a young man who was subjected to torture and other ill-treatment in detention, including sexual violence and then sentenced to death after a sham trial.
- “This execution lays bare once again how Iran’s criminal justice system is rotten to the core and highlights the Iranian authority's deadly resolve to use the death penalty as a tool of political repression to instill fear among the population. It also dispels any illusions of human rights progress with a new president assuming power last week.
- “The continuing arbitrary execution of protesters in the aftermath of the ‘Woman Life Freedom’ uprising illustrates yet again that without constitutional, legal, and policy reforms, human rights violations and impunity will persist. It also underscores the need for states to initiate criminal investigations under the principle of universal jurisdiction against all those suspected of criminal responsibility for crimes under international law, including top Iranian **officials.**”<sup>5</sup>

### **Reports of the attack on Evin women's prison following the protests against the execution of Reza Rasaei**

On Tuesday, August 6, 2024, the women's ward of Evin prison was attacked following the protests and the execution of Reza Rasaei, a Kurdish political prisoner. Following the protest of the prisoners of the women's ward of Evin prison to the execution of Reza Rasaei and the attack of the security guard, Several political prisoners were injured in the women's prison. They were taken to the prison **health care.**<sup>6</sup>

Until today, August 7, 2024, according to this former political prisoner, the phone calls of these prisoners have been cut off, and there is no information

about their condition. Many people have been severely punished. There is no information about the severity of the injury or the fate of the women. The phones in this ward have been cut off, and the BBC has confirmed the women's ward's "phone disconnection" and the concerns of the families. It said that following the attack, "some people have been injured, including three people. They were taken to the hospital who had become ill during the crowds." Alihe Motalebzadeh, a photographer and women's rights activist, also wrote: "Reza Rasaei was executed, and that is in the days when we are all worried about conflict and the outbreak of war." In the meantime, the news tells about the officers attacking the prisoners of Evin women's prison and fighting with them because the female prisoners did not remain silent in protesting the news of Rasai's execution and repeatedly asked the people to shout no to the execution.

Reza Rasaei was made a political prisoner, and among the detainees of nationwide protests on August 6, 2024, he was executed in Dizelabad Prison, Kermanshah, "without informing his family, lawyer and the right to make a last visit." This 34-year-old prisoner, **who was from the Yarsan minority**, was denied the right to access to a lawyer on November 24, 2022, and the other part of his case is under investigation in Isfahan Criminal Court No. 2. Mehrabi was arrested by security forces in Isfahan on June 29 this year. He was arrested for the murder of Nader Birami, the intelligence chief of the Sahne city army.

Mr. Rasaei had repeatedly denied this accusation and said in his trial that he was forced to confess by "torture and ill-treatment", but the Supreme Court of the Government of Iran accepted it as "evidence". Female political prisoners in Evin prison have already tried many times to raise their voices to protest against repression execution, and violation of human rights by the Iranian government despite being imprisoned. Maryam, the sister of Mahmoud Mehrabi, a political prisoner sentenced to death, was sentenced to 6 years in prison Sunday - August 2024 Maryam Mehrabi, a teacher and sister of Mahmoud Mehrabi, a political prisoner sentenced to death, was sentenced to six years of imprisonment, two years of suspension from service and two years of ban on leaving the country by the Isfahan Revolutionary Court. According to the verdict issued by the first branch of Isfahan Revolutionary Court headed by Judge Mohammad Reza Tawakoli and delivered to Mehrabi on Sunday, August 4, 2024, he was sentenced to one year in prison for the charge of "propaganda against the regime" and for the charge of "abducting or inciting people to war" and killing to disrupt the security of the country" has been sentenced to five years in prison.

Mehrabi has also been sentenced to two years of suspension from service and a two-year ban on leaving the country. Mahan (Hajar), Maryam's sister, released a video announcing this news and said: "Has Maryam done anything but sue for my brother?" In this case, this political prisoner was denied the right of access to a lawyer, and the other part of his case is being investigated in the criminal court of Isfahan.

Mehrabi was arrested by the security forces in Isfahan this year (July 18, 2024).<sup>7</sup>

**Maryam Mehrabi, the teacher, is on a hunger strike in prison in Isfahan.**

According to the Coordinating Council of Trade Union Organizations of Iranian Cultivators, Maryam Mehrabi, a teacher living in Isfahan and the sister of Mahmoud Mehrabi, a political prisoner sentenced to death, has been on a hunger strike since Monday, August 15th, in protest against the issuance of a prison sentence and additional punishments against her, in Daulat Abad Prison, Isfahan.

According to reports, the physical condition of this imprisoned teacher is serious, and yet he was transferred to solitary confinement instead of treatment.<sup>8</sup>

**Rasul Bodaghi is a teacher who is associated with honorable and tireless demands.** Bodaghi was arrested, imprisoned, and fired immediately in December 2009. During the seven years that he was imprisoned, he was deprived of his fundamental rights even in prison, so he was not allowed to attend his mother's funeral and mourning ceremony because he was not given even one hour during the entire period of seven years. They did not take leave. He spent a long time in solitary confinement. Still, he never gave up on his lofty goal, which was to pursue the rights of teachers and students and to try to improve the country's disordered education situation. He continued selflessly and without the least expectations in the field of activism.

Rasul Bodaghi was arrested and imprisoned again on April 30, 2022. After this date, he went on leave for only 4 days for his daughter's marriage ceremony and was immediately sent back to prison.

More than two years have passed since his imprisonment, and he is still deprived of leave. His lawyers' efforts for his release have been unsuccessful, as they rejected the resumption of proceedings in the Supreme Court. Recently, their phone calls had also been restricted. With all the sufferings that have been inflicted on Rasool Bodaghi, he never complains about the oppressions that have happened to him, but about the violation of the rights of teachers and students, the lack of modern and fundamental education in Iran, and the educational inequalities of his voice from prison. He was also taller than all the activists in this field. We, a group of Iranian teachers, workers, trade union and civic activists, and the signatories of this text, while condemning the oppression of Rasool Bodaghi, want to stop the double oppression and sufferings inflicted on him and his family. Rasul Bodaghi is not a "name" but a "path."

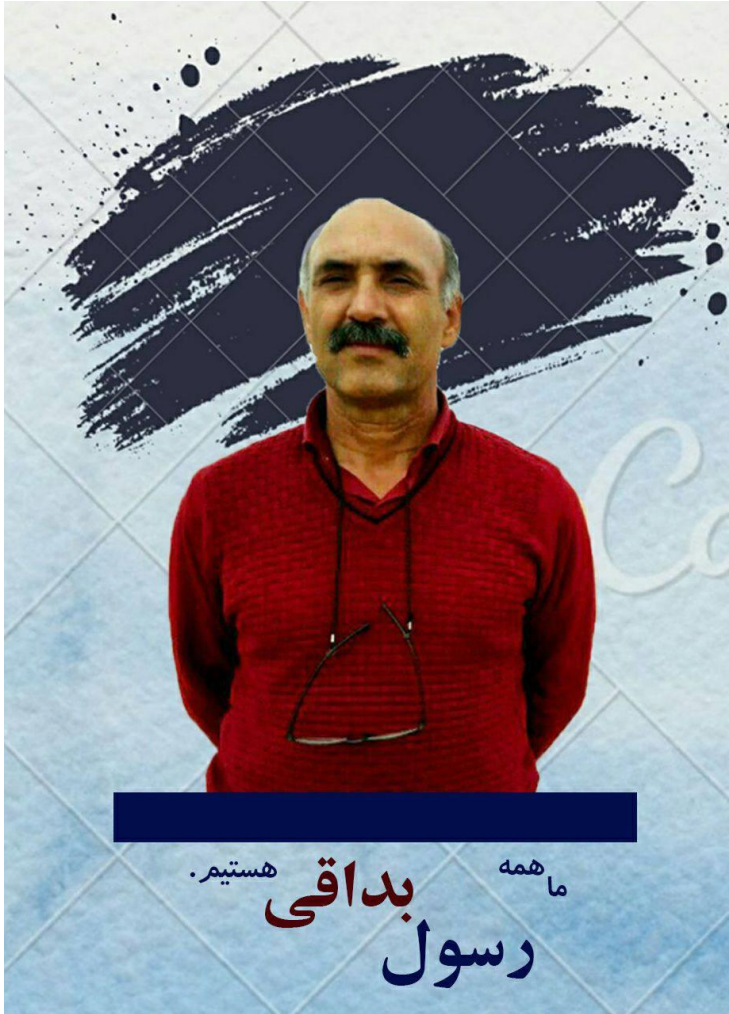
The path of union demands and honorable activism... The messenger of Iran's teachers should be released.

**On August 4th, sixteen prisoners in Ghezel Hesar Prison in Karaj, who had previously been sentenced to death for non-political crimes, were transferred to solitary confinement for the execution of their sentences.<sup>10</sup>**

**This transfer is for the execution of their death sentences. Four of them had previously been sentenced to death for murder charges. Additionally, five of these prisoners are Afghan national.**

**Further details, including the identities of these prisoners and the charges against the remaining twelve prisoners, are being investigated by HRANA.**

**In 2023, the Department of Statistics and Publication of Human Rights Activists in Iran registered the execution of 767 individuals. Out of these, 7 were carried out in public. Among the executed individuals whose genders were identified, 21 were female. Additionally, 2 juvenile offenders, defined as individuals under the age of 18 at the time of their alleged crimes, were also executed.**

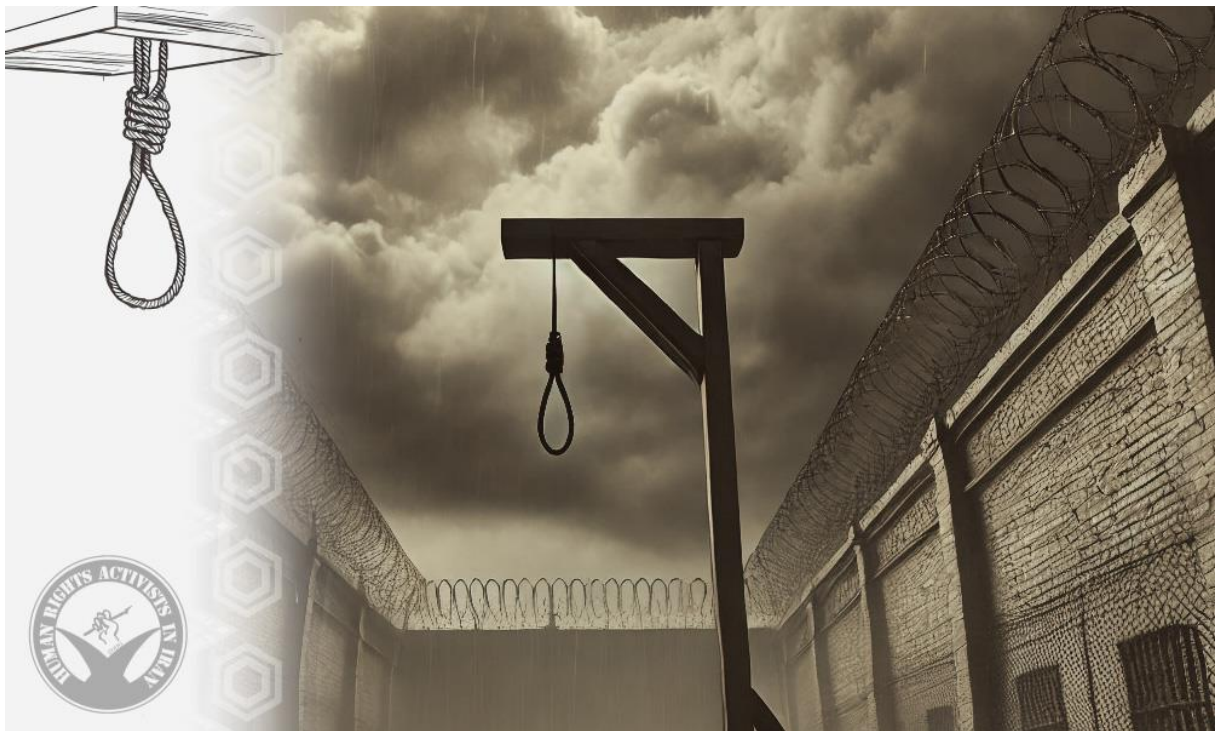

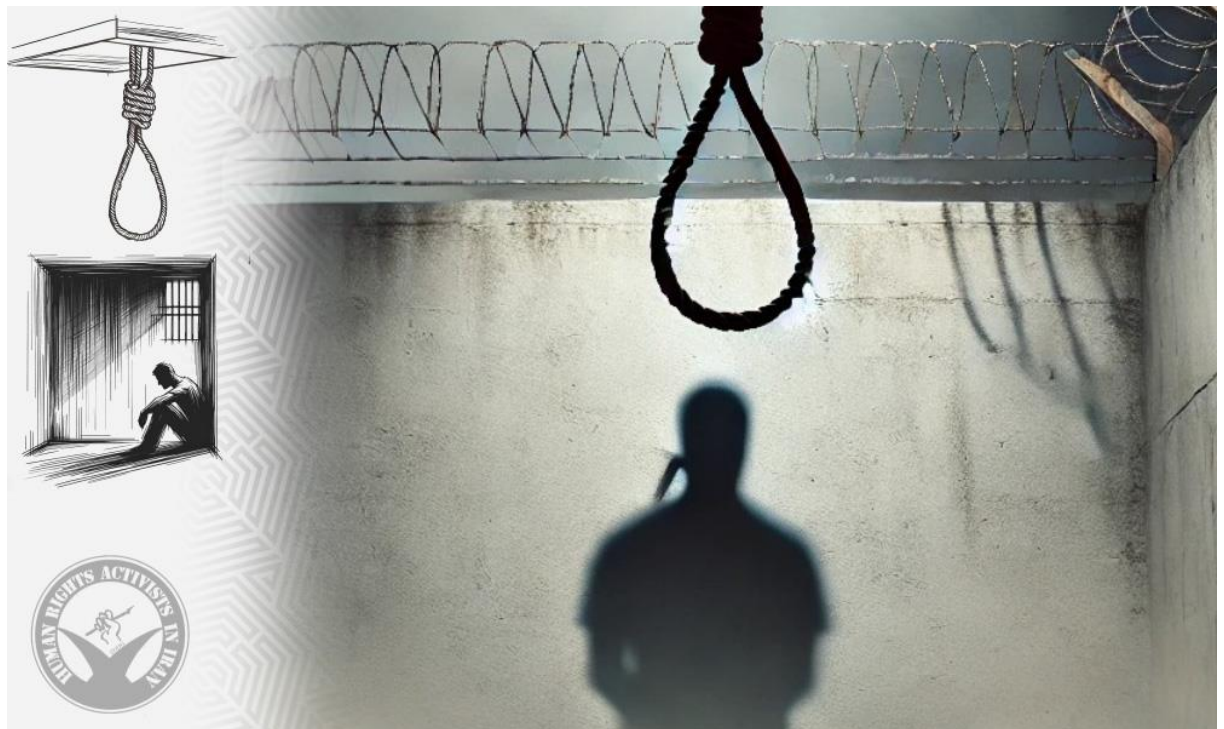
